The impact of student projects

Safe use of wheelchairs on the ICUs

It is really important to ensure that the wheelchairs used on the ICUs are safe for the patient. These should be assessed to ensure that the patient has a wheelchair provided for them that is the correct size and fit and is fitted with pressure relieving cushions when needed. The wheelchairs must be properly maintained, and non-standard accessories should not be added to the wheelchair. Wheelchairs should be assigned to one patient for their admission or cleaned in between every patient use. A "Safe Use Of Wheelchairs" guide should be displayed on ICUs and made available to all ward staff, and is attached to this newsletter. Please do check it out!

Patient Safety News Flash — Patient Safety Training!

The Patient Safety Team are delighted that the NHS has launched the national Patient Safety Syllabus level one and level two training. This is easily available on ESR. The delirium alert on SystmOne

A recent incident in one of the ICUs highlighted that a patient diagnosed with mild delirium did not have the delirium alert activated in SystmOne. Instead the dementia alert was used in error. The delirium alert would have helped to raise awareness for the staff involved in the patient's care and may have improved the patient's experience more effectively. Please remember that the delirium alert is a useful tool for staff who are supporting patients who present with delirium on the ICUS or in the community.

Herbert Protocol—Sussex Police

"The initiative is named after George Herbert, a war veteran of the Normandy landings, who lived with dementia. He died whilst 'missing', trying to find his childhood home."

"The Herbert Protocol is a form that carers, family or friends of a vulnerable person, or the person themselves can fill in. It contains a list of information to help the police if the person goes missing, including:

- medication required
 - mobile numbers
- places previously located
 - a recent photograph"
